I am profoundly honored to do this work and yet I am cast into this role by the natural forces of my life and the government, academic and institutional forces that oppose a natural and citizen inventor in visual art history painting

EQUAL ACCESS / COMPUTER EQUALITY / AMERICAN CIVIL RIGHT, RECOGNITION OF HANDICAP BY COMPUTER DISCRIMINATION BY EXCLUSION - "Computer Handicap Recognition and Icon" is the most important new civil right of the 21st Century.

9/1/2017 This new Civil Right and Icon was premiered and exhibited at our City of Fort Myers, Florida Art and Culture Grant Recipient Exhibition at the Sidney & Berne Davis Art Center , Fort Myers, Florida.

The next day our Exhibition was closed by Hurricane Irma Emergency Plan.

Today billionaire Elon Musk's company Neuralink will soon be implanting computers in human minds. Today Musk and notable scientists are calling for a halt in the imposition of artificial intelligence.

With the publication of my 2016 grant award and establishment of EQUAL ACCESS / COMPUTER EQUALITY / AMERICAN CIVIL RIGHT we can gain the tools necessary for government to legislate this new and dynamic imminent other reality of Artificial Intelligence.

Elon Musk and computer scientists are saying human destruction is inherent in the unregulated application of artificial intelligence and that AI is an unregulated nuclear bomb.

The City of Fort Myers is the only place and now is the only time we have to establish the foundations of ability to legislate Artificial Intelligence and establish sustainability for human governance and as a Democracy.

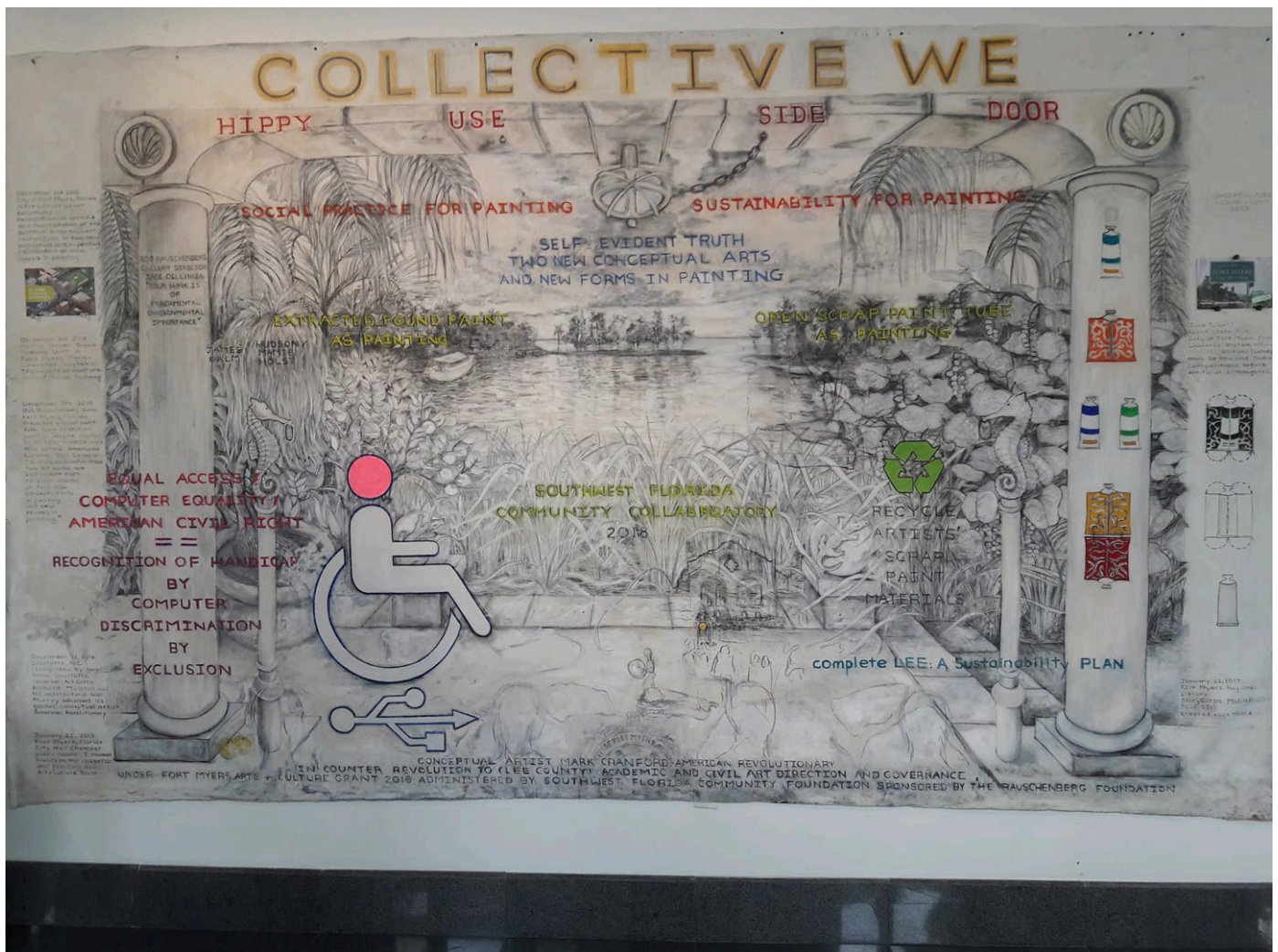

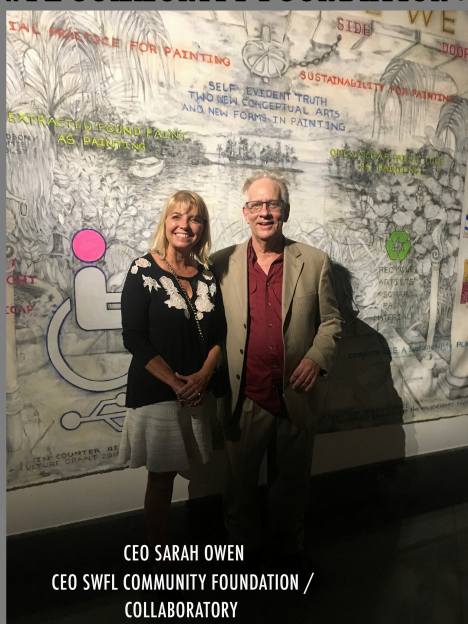
