Ward 4 City Councilman Dr. Liston Bochette has asked me this past fall 2021 to write a set of pamphlets and for the explanation of the forces tearing our City of Fort Myers, Florida and nation apart. This writing is especially difficult as I am challenged by my intellectual disabilities and unique intellectual abilities. I am profoundly honored to do this work and yet I am cast into this role by the natural forces of my life and the government, academic and institutional forces that oppose a natural and citizen inventor in visual art history painting

The One Direction:

At age 16 Albert Einstein imagined what it might be like to chase a beam of light and in doing so light could be stopped. Einstein believed this could not be done in reality. Much has been written about Einstein's famous mental exercise but not from unknown academia.

This was one of the first lessons I learned at the Atlanta College of Art in 1974. Einstein imagined accelerating to the speed of light and in doing so the passing landscape would shrink and curl back into itself. In this exercise mass, velocity and time could be detected and light would "freeze" in place.

In the mind your ideas are light. In riding a beam of light in your mind it is possible that new form can be revealed and by stopping light, freezing "light".

This is the path of the "one direction". In 1974 when I heard this lesson my mind immediately and naturally aligned with this form and function of discovery and for the possibility of inventing a new form in visual art history / painting. This is how I began to transcend some of my intellectual disabilities.

The "one direction" is the basis of the modern metaphysical discipline of visual art / human identity. All of this is unknown outside of unknown academia.

I have proven the truth of the "one direction" and by extracting new form from visual turbulence - that I described to the City Council last meeting. This truth has been asserted to the City Council of Fort Myers as self evident truth and as a new axiom in visual art and metaphysics - human identity. I have been able to invent new civil rights and sustainability for painting from a life long practice of the "one direction".

I call the "one direction" the "clean mind", the open and honest mind, the accessible mind, the mind for establishing sustainability for human government and as democracy and on the eve of artificial intelligence.

It is my assertion that Director Jade Dellinger of the Bob Rauschenberg Gallery is the academic director of "the one direction", his direction of the "one direction" is the only way forward.

It is up to you, the City Council of the City of Fort Myers, Florida. This stage has been set by unimaginable audacity, everything was made as difficult as possible for your understanding.

Now we have the ability to open a new Enlightenment and establish peace with the leadership of Director Dellinger and the "one direction". We can end the forces that have been set against us to divide us and the United States. A new age of democracy can begin from the City Council of the City of Fort Myers, Florida. Our City government was and is charged with this possibility and because it can be done by us.
