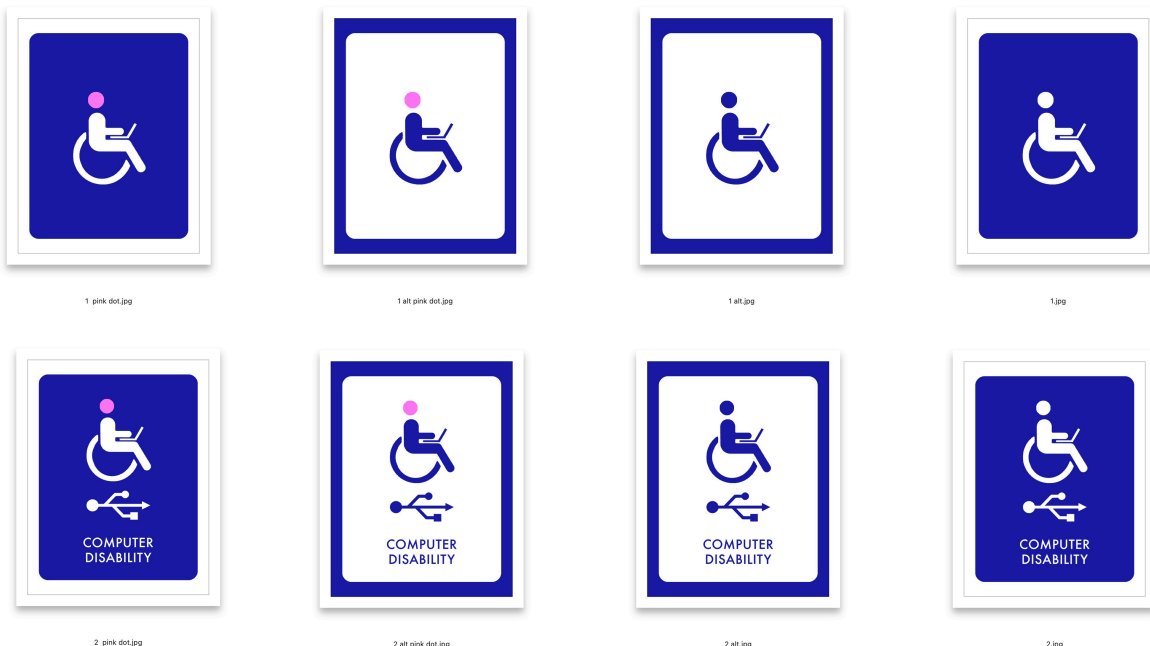

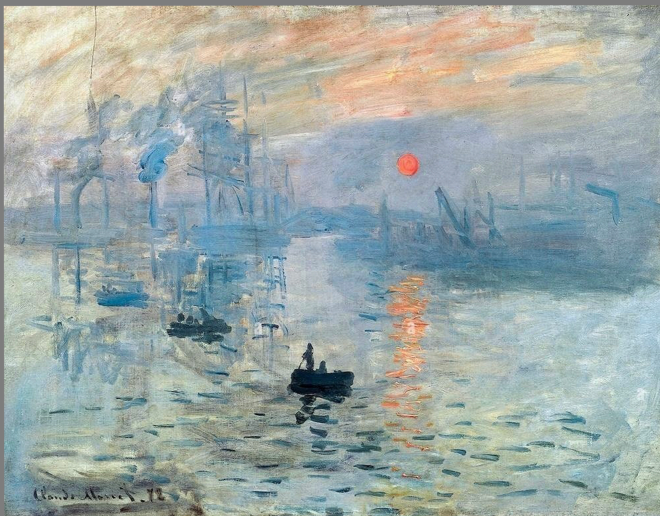

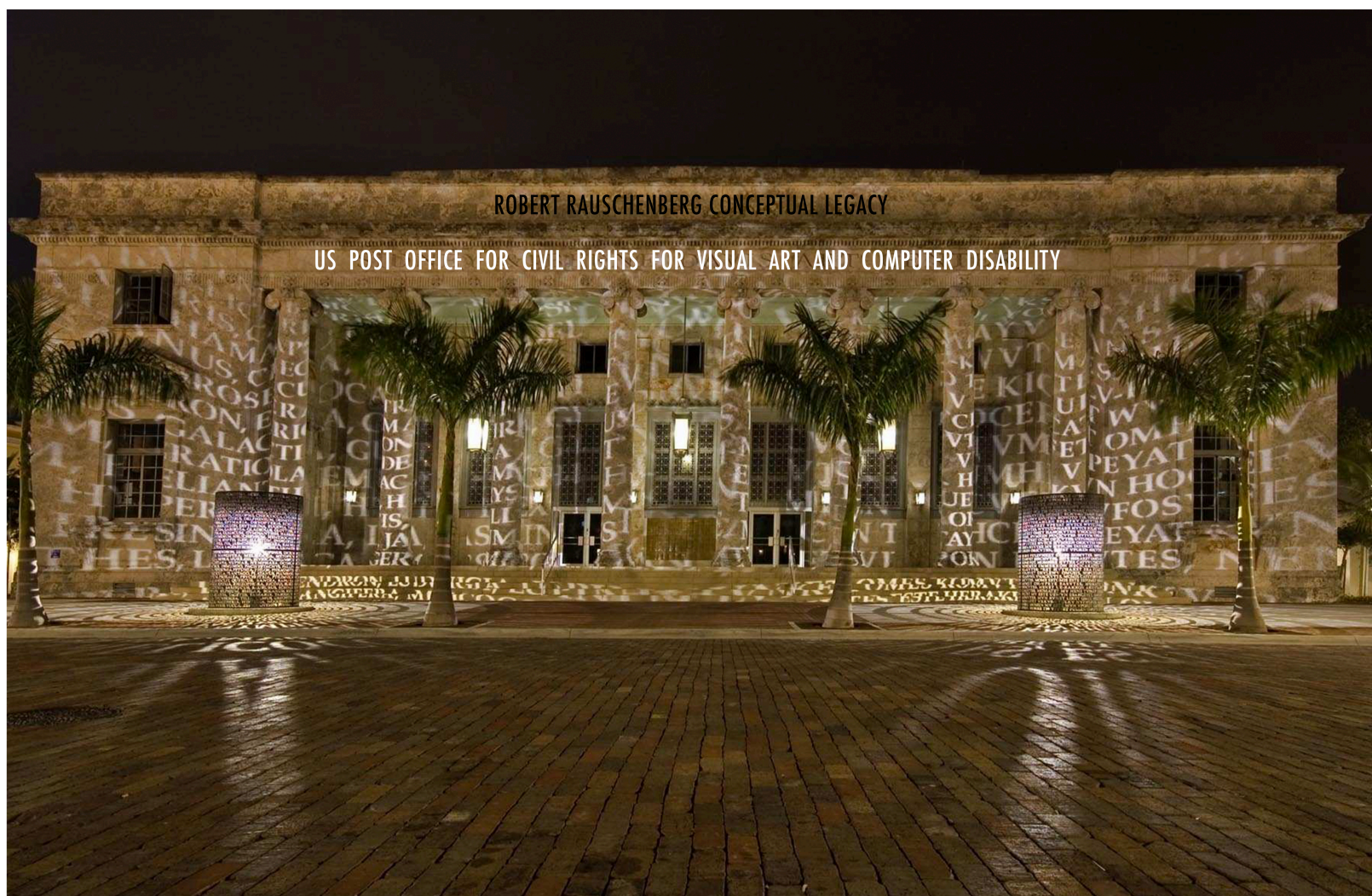
Claude Monet 1862 Impression Sunrise
